Highlights of the report include:

- 8 of the 12 Honor Council Delegates made the Dean's list in Fall 2016
- More than 9,000 students, parents, faculty, and staff have attended Honor System presentations.
- More than 4,000 students have completed the Academic Integrity and Student Success Online Learning module
- The Undergraduate Honor System conducted more than 4,800 consultations with members of the academic community between November 2016 and February 2017
- More than 402 cases have been reported or resolved this academic year
- Case resolution time has decreased from around 60 class days to 15 class days in most cases, promoting a fair and timely response for both faculty and students
- 83.8% of cases were resolved through the new Faculty-Student Resolution Process
