Through surveys to faculty and students, we found there was overwhelming support to have Labor Day off if no other calendar changes were made. In addition, we also found that the vast majority of our peers currently have Labor Day as a non-class day. However the committee also found that adding a non-class day would have a disproportionate impact on laboratory instruction. As a result of this work the Academic Support Committee is not recommending a change to the calendar criteria for Fall of 2016. The committee will continue its work on this topic and will now consider if a 71 day semester will meet Virginia Tech's academic needs.
