 - Record highs with giving model in terms of revenue
 - \$6 Million increase
- Spring Game this weekend
- AD Honor Roll Breakfast
 - Honors top student-athletes

4. New Rules on Exam Proctoring for SA while traveling

Matt Mayotte, Director, Student-Athlete Academic Support Services

- While traveling, athletes may have to take an exam on the road, 4 levels of oversight
 - SAASS counselor if traveling with the team
 - o Host institution SAASS advisor
 - o Equivalent of our student success center at host institution
 - Compliance officer
- Important to have written guidelines for consistency as these situations arise

Danny White, Associate Athletics Director of Student-Athlete Development

- Money from the NCAA distributed to all institutions
 - o #of Pell Grant Recipients
 - o #of Sports
 - #of scholarships
- Money to be provided to student-athletes with strong financial need
- Four categories of SAF Expenses
 - Educational Expenses and Fees
 - Summer School
 - Grad School Exams/Fees
 - Supplies
 - Health and Safety Expenses
 - Insurance
 - Medical/Dental/Vision
 - Personal or Family Expenses
 - Clothing
 - Travel
 - Inst. Academic or Programming Enhancements
 - Learning Assistance Program (SAASS)
- 14-15 Expense Overview
 - Highest Expenses
 - Educational
 - Biggest is computers for full-scholarship SAs
 - Health/Safety (Insurance)
- 15-16 Changes
 - o Massive increase for insurance premiums
- ACC SAF Overview
 - o Similar with educational and health and safety being the highest

- We spend a little more on health and safety
- Biggest challenge is coving Insurance premium expenses
 - o Cover full scholarship international student-athletes (53)
 - Those who are uninsured or under-insured (32)
- COA changes how we use SAF
 - o More money to partial scholarship SAs vs Full scholarship
 - Provided check for materials to 227 partial scholarship SAs (things the are required for class that are not books)
- Assistance with study abroad costs
- Emergency travel
- Spending money in ways that are sustainable

- Do the computers become personal property?
 - o Yes, once the graduate

- Kigali, Rwanda (May 12-26, 2017)
- High level policy drivers
- Three Themes
 - International Development
 - Sport for Development
 - o Global Citizenship
- Always incorporates some form of service
- Class in morning, meeting with an organization in the afternoon
- Other: Akagera National Park, Kigali Genocide National Memorial

- What are the out-of-pocket costs? How do we support?
 - o \$2800/student
 - o student-athletes can apply to SAF (can cover \$2000/student)

8. Budget and Facilities

- Reviewed reports from Tom Gabbard and Omar Banks
- Procedures and policies ensure NCAA compliance
- Major Revenue generator (\$19.4 million) fund all other programs
 - o Football

- o Men's Basketball
- Debt service payment planning
- Facilities work-in-progress
- Excellent plan for constructing/maintaining/improving facilities
- Administrative accounting etc
- Significant head coaching hire financial impacts
- Could be improvements difficult to compare female team's coaches' salaries to men's team's coaches' salaries

9. Compliance

- Access to facilities
 - No specific rules or regulations
 - Need to restrict access varies by sport
 - o Generally monitored by the coaches
- Compliance provides education about impermissible contact with donors, etc
- Program for football teams and families about agent interactions
- Compliance office is being proactive about educating student-athletes about he rules and regulations

- Bridget McSorley, Pam Linkous, Reyna Gilbert-Lowry
- Diversity
 - o "highly recommends" hiring more diversity
 - o student-athletes are more diverse than university as a whole in some ways and less diverse in others
- Equity (Title IX)
 - o 2 requirements
 - Equal Access proportionality
 - Equal Treatment equitable financial assistance (male vs female)
 - Financial aid (favors females)
 - Summer aid (doesn't count for title IX)
 - More males enroll in summer school
 - o Positive improvements in diversity in the faculty/staff
 - o FB and Basketball are allowed to have mandatory activities in the summer
 - That is why the numbers are primarily male (B. McSorley)
