**1. Introduction of SGA Student Reps**

**2. Advising Update:**

- Review questionnaire developed by Stacy and Kim Smith to collect advising perceptions of Pathways
- Would be built in Qualtrics and send out to all advisors (mix of likert scale and open-ended
- Goal: get at advisor comfort, competence of curriculum... feel they have the recourses they need to do their jobs
- Suggestions: Remove #6 (redundant with #7)
- #3: could define and then ask... about distributive model OR use different phrase (e.g. credit hour requirements)
- Program review subcommittee would like to take on inventory of course availability from the very beginning of their work
- Program review subcommittee would like to also get direct feedback from students
- Could do focus groups to get at student perceptions

**3. Concern about Capacity in Adv/App Quant/Comp Concept:** Stacy

- Came from advisors in CLAHS – adv/app quant/comp for NON-STEM majors (e.g. aligned with calculus)
- 745 seats available for students without Calculus or not in certain majors
- See handout for list of Quant/Comp courses with enrollments
- Some listed are for only certain majors (e.g. for only certain engineers)
- Also need to consider what's in the degree core

Discussion:

- How many students do we NOT have to worry about? Engineering, COS, etc.
- Reminder: transfer students come in under CLE as opposed to Pathways
- Have some time to get the Adv/App courses in place since many students won't be taking these courses until Sophomore year
- How do we encourage courses to develop courses in these high-need areas?
  - o Pathways Grants
- PIBB Model = ever-moving target, should be a premium for Pathways, Pathways Minors, etc.

- Similar issues with Adv/App Discourse, Arts/Design, Identity/Equity
- Some still coming in...
- When are courses offered (summer, winter)

#### 4. **Transfer Appeals:**

- Explanation and discussion of VCCS Poli Sci Transfer Course Review and VA Passport
- Discussion: stakes are high for this review because it is a blanket gen ed credit across the whole state = typical syllabus (from Tidewater Community College, specific professor, specific course)
  - o First part of syllabus is standard across VCCS
  - o Jill thinks it aligns with Social Science outcomes 2, 4, 5
