- There is no published hierarchy or definitions for majors, major options, and minors. Providing clarity on requirements for these programs would assist curriculum committees and potentially aid in the discussion of overlap between academic programs.

- There is no policy to define how much a minor and major can overlap. Depending on the college, some programs require that minor requirements cannot overlap more than 50% percent with their major.
- Many programs at the university can overlap. The commission needs to consider the reasons why overlap is concerning and how that may affect current programs.
